The RRPS Board of Education holds its regular meetings at 5:30 PM on the second and fourth Mondays of each month except for December and May, when the Board schedules only one regular meeting. Meetings scheduled on dates other than the second or fourth Monday are asterisked (*).

The Board's regular in-person meetings take place in the Board Room at the RRPS **Training Center, 500 Laser Rd. NE.** Regular and special meetings are livestreamed through the RRPS YouTube **Channel**. Committee meetings and workshops conducted in person are usually not livestreamed, but are open to the public unless the Board is meeting in executive session subject to the exceptions provided in the New Mexico Open Meetings Act.

Board meetings may be held virtually as determined by the Board per district policy #208. If the meeting is virtual, the meeting notice and agenda will include that information. If in-person public attendance is not permitted, members of the public may view a livestream of the meeting via the RRPS YouTube channel (except for executive sessions closed under the provisions of the Open Meetings Act), and submit comments in advance through our Public Comment form.

The Board of Education is occasionally involved in recognition, training, and other activities at which a quorum may be present. The Board does not conduct public business at these events except as is required in association with the activity (e.g. acceptance of a school's graduating class). Board members also participate in New Mexico School Boards Association (NMSBA) training and networking activities. State statute requires that each board member complete at least five hours of annual training through NMSBA and New Mexico Public Education Department-sanctioned sessions.

Audit Committee meetings:

The RRPS Board of Education Audit Committee meets monthly, as required by statute, while the district's annual audit is in process, usually from June through September or October. These meetings include a brief open session to handle procedural matters, followed by a closed executive session as permitted under NMSA 1978, Section 10-15-1 of the Open Meetings Act, Section 12-5-6 of the Audit Act, and the confidentiality requirements of NMAC 2.2.2.10(M)(3), specifically for the purpose of discussing matters pertaining to the Rio Rancho Public Schools FY 24 audit. Audit Committee meeting dates for 2024-25 are currently anticipated to be: July 22, 2024, August 26, 2024, September 23, 2024, and October 28, 2024, with a final meeting (exit conference) scheduled in late October or early November.
